None of the contract negotiations or any of the services provided by Supplier under the Agreement or the Supplier Professional Services Deliverables will constitute any legal opinion or advice.
5. Supplier has based comments, recommendations and the Supplier Professional Services Deliverables on information provided by Customer and the Third Party Suppliers. Supplier is not responsible for the completeness or accuracy of such information.
