Vendor and CWT agree that terms of modules available on links specified and designated for incorporation in Module MM are incorporated into the Agreement as if included in hard copy. Module content reflects mandated CWT standards however, if exceptionally CWT should agree minor variations, any restated module included with Module MM before signing in hard or digital copy shall prevail over standard module terms.

Vendor and CWT agree that prior to product or service provisioning by Vendor or payment obligation on the part of CWT Module TS is to be adapted with details of products and services to be contracted and signed in hard or digital copy between CWT and Vendor (SoW), upon which SoW becomes part of, and subject to all terms and conditions of the Agreement. Multiple SoW's may be made under the Agreement provided that CWT may at its sole discretion require the inclusion of an updated Module MM with any supplementary SoW prior to signing. Modules may be updated automatically if agreed by CWT and Vendor. Where modules are updated the latest module content will apply to the new SoW and all prior SoW's from the effective date specified in supplementary Module MM or, in the case of automatic updates, the date of such update.

By signing below Vendor and CWT agree that a legally binding contract is formed by and between Vendor and CWT including Module MM, all other modules specified and all SoW's on and from the Effective Date for the SOW Term (Agreement).
